## 8. Village Issues

## a) Highways - Drains/Potholes/Gullies/Issues

## - Bus Shelter

Cllrs raised the issues again of the area in front of the bus shelter: buses and large vehicles have eroded the verge away leaving mud, potholes and standing water and with no lights in the bus shelter and dark nights this area is dangerous for bus passengers. Cllrs agreed the area needed to be kerbed and the road filled and tarmacked and asked the Clerk to contact NCC again.
